Course Description: This qualification reflects the roles of entry-level vocational education and training (VET) teachers, trainers and assessor who are delivering training services to vocational learners and assessment services to candidates. The roles may be undertaken by those working in registered training organisations (RTOs), enterprises, community organisations, schools and other VET provision contexts.

Articulation: On completion of this course you would be able to consider higher qualifications such as: TAE50122 Diploma of Vocational Education and Training.

Licensing/Regulatory Information: This qualification meets the minimum education requirement for trainers and assessors operating without supervision under applicable VET legislation, frameworks and/or standards.

Those entering this program must be able to demonstrate vocational competency in their proposed teaching and assessing area. Vocational competency is defined as broad industry knowledge and experience, and may include, but is not limited to, holding a relevant unit of competency or qualification.

Recommended Duration and Volume of Learning:

The volume of learning for the TAE40122 Certificate IV in Training and Assessment as a Learning and Assessment pathway is typically six months to two years. This may vary according to prior skills and knowledge.
